

APPLICATION TIPS for Best Results

- Shake bottle well for 5 seconds prior to every use
- Cleanse area as per facility guidelines; pat dry to remove residual moisture
- Prior to use, **prime sprayer away from patient** into disposable cloth or trash can by pumping until consistent spray is achieved
- Squeeze trigger quickly and with force to ensure an even spray (insufficient pressure may result in a liquid stream versus a well-dispersed spray)
- Hold the bottle 4-6 inches from skin during application; **no rub-in is required**
- A heavy coat is not needed; over-application, although not harmful, may cause fluid to drip down skin
- Product will become more translucent as it dries.
